# County Operational Area

County COVID-19 Recovery Team

- **Case Trends:** *as of 11/8/20*
  - Total cases: 26,490; total deaths: 433
  - Average daily case count has climbed steadily from a low of 95 per day in late September to 134 per day as of last week (and climbing)
- **Deaths & Hospitalizations** both on the rise
- While we continue to have lower transmission levels than much of the nation, the recent trend line is cause for some concern as we enter the fall and winter holiday season

# County Operational Area-cont'd (2)

- **County Remains in Tier 3 (Orange) in State Framework:**
  - High testing rates alone will not keep us in the Orange Tier
  - Must remain vigilant, especially as cold weather & holidays approach
- Information about Risk of Gatherings and Testing Availability on Public Health Facebook Pages:
  - Gatherings – English, Spanish, Vietnamese
  - Testing – English, Spanish
- Public Health Website & social media: information continues to be available in 5 languages

# Food Distribution (2)

Submitted by: B.Pillet – Second Harvest Silicon Valley

- From April to October the SH network provided food to ½ million individuals. November is expected to be lower.
- More than 350,000 are living in Santa Clara
- Calls to the hotline and web traffic are stable with higher numbers at the end of the month.
- We have distributed 13.5 million pounds of food in October. Highest month ever.
- CFAP box programs has ended at the end of October. We switched back to 100% in-house built boxes.
