Organize Non-Governmental Organizations (NGO)



Review completed work for each APN to verify all work is completed and sign off so that APN can be returned to Homeowner.



- ARSENIC
- COPPER
- CHROMIUM
- LEAD



Disaster Haz Mat



Debris Streams

Landfills are reviewed and approved at the early stages of the project.

Asbestos

 Must be taken to a lined Class III Landfill, permitted to accept asbestos

Chimneys

- If not containing asbestos, will be removed with ash/debris
- If containing asbestos, must be taken to a permitted and lined Class III Landfill

Vehicles

 Recycled as metal once the appropriate adjudication is completed

Metals

Taken to a metal recycling facility

Ash/Debris

- This is disposed of at an approved landfill
- Concrete
 - Recycled or transported to an approved landfill
- Soil
 - Disposed of at an approved landfill

*Hazardous Materials – Sometimes not all hazardous materials are located and removed earlier in the process. If found during debris removal, these are set aside for DTSC to conduct a pick-up.

Soil Confirmation Sampling

- Residual structural ash contains concentrated amounts of "heavy metals", such as arsenic, beryllium, cadmium, cobalt, copper, lead, mercury, nickel, thallium, vanadium, and zinc
- Asbestos is present in older home sites pre 1985 (ish)
- Lead is prevalent in older communities pre-1978

INSURANCE**

- The County is responsible for collecting insurance
- Only collect "debris removal" portion of insurance policy (if any)
- Do not take all insurance proceeds
- No charge to Homeowner if there is no insurance




Tips for reversing the damage done to your home during a

- •Detergent •Long pants •Bleach
- •TSP, iPales Ned Yn yothiatea •Shopt vac dyrstanister vac off (no tennis shoes or flip flops) •Spo Weesk gloves
- •Buckyes protection
- •Rubbespedstatsle masks
- •Monsandubreoms
- •Shovels and rakes, if mud or other debris has entered your home
- •Carpet knife, if wall to wall carpeting will need to be removed
- •Heavy duty trash bags

















Key Learning – A Joyful Day



- Motivation when actually seeing and feeling survivors' sufferings and needs.
- Coordination of locations and manpower is challenging.
- Connection and recruiting through community or faith based organization.
- Trust and communication protocol established ahead of time.
- Safety and care: appreciated by volunteers.
- Team spirit: creates sense of belonging and supporting.
