County Operational Area

- **Case Trends:** *as of 10/9/20*
 - Total cases: 22,312; total deaths: 357
 - 7-day rolling average: ~94 new cases per day
 - Case counts have declined since mid-August
 - Higher rates among Latinx and African American population since June, but rates declining since mid-August
- **Deaths:**
 - After a decrease in June, there has been an increase in newly reported deaths since mid-July
- **Hospitalizations:**
 - Number of COVID+ hospitalized patients decreasing since late July

County Operational Area-cont'd

- **County Remains in Tier 2 (Red) in State Framework:**
 - K-12 schools can open for in-person instruction without a waiver, so long as they follow all State & County requirements
 - Decision is up to individuals schools/school districts
- **All data and tier assignments are updated weekly on Tuesdays** – could move into Tier 3 (Orange) as soon as this week
- **Health Equity Metric**
 - Census tracts divided into quartiles based on score on Healthy Places Index
 - Positivity calculated across census tracts in lowest HPI quartile
 - Does not change SCC's tier status – positivity rate for lowest quartile HPI is the same as the tier assignment

County Operational Area-cont'd

- **Revised Risk Reduction Order Issued 10/5/20**
 - Goes into effect when SCC moves into Tier 3 (the Orange Tier)
 - Generally allows all business in County to operate if the State allows them to be open
 - Indoor dining & indoor gatherings may resume when SCC enters Orange Tier with capacity limits and distancing requirements
 - *Revised order does not mean that the Health Officer considers all open activities to be safe*

Food Distribution (2)

- From April to September the SH network provided food to more than ½ million individuals. October will still be in that range as well.
- More than 350,000 are living in Santa Clara
- Calls to the hotline and web traffic are staying above February's level but stable.
- We have distributed 11 million pounds of food in Sept.
- We expect the CFAP box to end at the end of this month and looking at our labor needs to replace them with internally built boxes.
